Results of Consensus on the Federal Government's Role in Public Education

We determined that we feel that the role of the federal government in public education is "about right" and that a quality public education is very important. The federal government should act to make sure that this is the case in every state but not micromanage each state's policies. Common core standards should be developed on a federal level but not mandated in order to receive any federal funding. We do not believe that special programs sponsored by the federal government should be mandated to any state, but we agree that programs should be available should states wish to participate. There should be a national assessment aligned with common core standards available for any state that wishes to use it to evaluate meeting objectives. The federal government should have a national curriculum that is available for use but is not mandated. The federal government should inform school districts of how their students compare to students similar to theirs. We also believe that funding for federal programs should be non-competitive for states and schools who meet the basic requirements of qualifying for the funds. If a program is mandated, we strongly

believe it has to be funded prior to expecting any school or state to implement it. We want equitable access to high quality teaching/learning, adequate and current learning materials, and clean and well maintained physical facilities. It is our strong feeling that the federal government should provide a supportive role and not force mandates.

How To Track a Bill in the Legislature

Sign the Utah Compact Anniversary

A year ago a short document, the Utah Compact, was written and publicized with the aim of

influencing the policy discussion on immigration reform and treatment of illegal immigrants. The League of Women Voters of Utah signed on as supporters. The Utah Compact includes statements on federal primacy, law enforcement, families, the economy and free society.

Since then laws in Arizona, Alabama and Georgia show that the principles set out in the Compact are even more relevant than they were a year ago. The United States is still in dire need of reasonable, compassionate and prudent reform of our immigration laws. Authors of the Compact have asked supporters to renew their support by asking friends and family to read and sign the Compact http://www.theutahcompact.com/ and by contacting members of Congress and asking them to support it.
