Empowering Voters. Defending Democracy. Chris Carson, National LWV President

In June, the Supreme Court ruled that partisan gerrymandering is a political question because no fair test exists for courts to determine when partisan gerrymandering has gone too far. That means all federal courts will be hands-off even when redistricting intentionally decreases the voting power of voters based on their political party.

Because redistricting has long been a priority issue of the League, and a signature part of our Campaign for Making Democracy work, we cannot sit back and wait for the court to change. We do not have to rely on the Supreme Court to solve partisan gerrymandering. There are other paths to creating fair maps nationwide – and the League of Women Voters is the best organization positioned to accomplish this.

We are launching a 50-state campaign called the People Powered Fair Maps Campaign.

The national board has authorized half a million dollars to launch this campaign, and every state League will receive some of that funding through grants. This work will look different in each state. Our state league will be providing specific information for Utah soon. Take a moment to search for this campaign and learn about it.

VOTE YES!

Vote YES! for Proposition 3 on our 2019 Weber County General Election ballot. What it says: "Shall a study committee be appointed to consider and possibly recommend a change in Weber County's form of government?" A YES! vote begins a process where a committee is appointed to study whether a change from the current form of three county commissioners to one of the three other state sanctioned forms would be in the best interest of our county. A YES! vote simply says a study committee should be created.

The League of Women Voters of Weber County has supported this since "Weber County Government Today: Options for Tomorrow?", our first study in 1981, was completed and consensus taken. In 2014 we again looked at this issue, updated our study, and developed a position statement that largely mirrored the 1981 position. Our position is: The Weber LWV supports the principle of some form of representation by geographic area based on the principle of "one person, one vote" as it pertains to county governance. The Weber LWV

supports the concept of separation of legislative and executive powers as it pertains to county governance. The Weber LWV supports a change in the structural form of Weber County Government based on the larger population and demographic changes in the county.

Prior to 1972 the Utah Constitution required that the Legislature establish a system of county government that was uniform, the same, throughout the state and the result was the 3 Commissioner form. In the 1960s our counties began to become more diverse with greater differences in populations, rural/non-rural areas, wealth, and economic opportunities. This was largely behind the movement to amend our Constitution to provide alternative forms of government so counties might be better able to carry out their functions, given their differing demographics. In 1972 the Constitution was amended so that the Legislature could prescribe optional forms of county government that might better serve their needs. The 3 Commissioner form of government would remain the default form unless a process was begun within a county to look at alternative forms. That process could begin with a YES! vote for Proposition 3 this year.

Weber County is becoming even more diverse with communities in the western part of the county experiencing rapid population growth. There are about 250,000

residents in the 15 communities and unincorporated areas of the county. The current form of government allows at-large representation of the three commissioners, virtually ensuring that many geographic areas will not feel adequately represented. Allowing for "some form of representation by geographic area" would support the one person, one vote principle giving county residents more of a sense of their voices being heard.

While the population has increased, so has the list of responsibilities and Special Function Boards the three commissioners oversee. They also are uniquely both the legislative arm of the county and the executive arm of the county. They are accountable for developing policies for the county and then are also accountable for administering the functions in the county affected by the policies they developed. This lack of separation of legislative and executive powers

provides no checks and balances, a principle of governance considered very important. Two of the three alternative forms of county government provide for a separation of legislative and executive powers.

There is an often used saying, "If it's not broke, don't fix it." Some might look at the seemingly well functioning current commissioners with no big conflicts or two-against-one behaviors that have surfaced in past years and use

that saying to justify a NO vote on Proposition 3. We believe that makes this an ideal time to vote YES! as well as the fact that these three commissioners themselves passed a resolution in September, 2018 to put the question on the ballot, "Shall a study committee be appointed to consider and possibly recommend a change in Weber County's form of government".

Now is the perfect time to study and reflect on our current form of county governance and see if there might be a better way to meet the county's growing population and diverse community needs. The Weber LWV believes the answer is yes and urges you to spread the word about Proposition 3 and the reason everyone should vote YES! on their 2019 General Election ballot.
